

Notes for the Physics GRE to Ace

pGRE stands for Physics subject test for Graduate Record Examination (GRE). This test is designed and taken by Educational Testing Service (ETS). The test consists of 100 questions with 5 choices, and you have 2 hours and 50 minutes to do it. This means, you only have an average of 1.7 minutes per problem. This is why many test takers found it's difficult. But, I want to note here from the very beginning, there are some tricks that makes calculations much simpler and which do not require special knowledge.

Unlike general GRE and TOEFL, pGRE is a paper-based test. And, it yields a total score on a 200 to 990 score scale in 10-point increments. Most of the questions can be answered on the basis of how much knowledge and understanding do you have in your first three years of undergraduate physics. You must use International system (SI) of units. You are not allowed to use a calculator during the test. But, the test center will provide you a table sheet of information representing various physical constant and a few conversion factors, log book, pencils, and test book along with the bubble answer sheets. Do not worry about you cannot do calculations without a calculator because it's enough to know or guess an answer out of five from your approximate numerical value. Even though pGRE will test your physics solving brilliance but it may also test your ability on certain mathematical method and their applications in physics. We are lucky that nothing is subtracted from a score if you answer a question incorrectly or leave it blank. But, in the past, they used to penalize incorrect answer by subtracting one quarter per incorrect answer from your score.

The pGRE is offered 3 times per year, in April, September, and October. Most people prefer to take pGRE either in September or October. It's up to you. The cost of the test is 150\$ all around the world. You can send four scores for free after you gave your test. But in TOEFL, you can add/delete/modify your score recipients after you register for that test. For an additional score report per recipient, you need to pay 27\$. You can view your scores online from your ETS GRE account for free. The reason we need to send our score to the University (i.e. score recipient) in-order to authorize our score. This means if you send your score by your email account or uploading score's pdf from application portal, the admission committee will consider it as unofficial. Your scores can be reportable for five years following your test date. For example, scores for a test taken on October 27, 2018, are reportable through October 26, 2023. If you want to register for pGRE from Nepal, you need to go to Nabil Bank either at Teendhara (Durbar Marg) branch or Chabahil branch, Kathmandu. Please make sure you have created an ETS

account for GRE along with your personal information. Because, you cannot register for the GRE test from your TOEFL account.

Let me give you some insights of the pGRE syllabus by ETS. This is given below.

Before I start, it will be fruitful if I give you some relevant tricks to tackle the pGRE problems. These tricks will also be mentioned more elaborately in each section. The tricks goes like these:

- **Always Guess:** If you can eliminate at-least one answer then, guess it.
- **Order of Magnitude:** Your arithmetic does not need to be exact so, I suggests you to save time by neglecting decimal larger than 1 or 2.
- **Dimensional Analysis:** You can eliminate some possible answers because they have incorrect dimensions. If you can figure it out, it obviously save a lot of time. You probably have known that mass (M), length (L), and time (T) are the most commonly used fundamental units in the Classical Mechanics. I mean, every physical quantities (i.e. force, momentum, and so on) in this topic can be expressed as the products of powers of these.
- **Take limits:** It would be a good step, if you check the given five choice answers to see if they really make sense within certain limits.
- **Put suitable values:** If you can put values inside the expression or formula given in the choices then, you get a number. Now, your cleverness is to guess which number is reasonable for the given problem.

I want to note here, you need to memorize some important values which will not be given in the formula sheet of your test book. These are shown below.

- 13.4 eV -Maximum binding energy for Hydrogen atom
- $931.5 \text{ MeV}/c^2$ -Energy equivalence with one atomic mass unit (amu)
- 1.007316 amu -Mass of the proton
- 1.008701 amu -Mass of the neutron
- 0.000549 amu -Mass of the electron
- $511.4 \text{ KeV}/c^2$ -Energy equivalence with the mass of one electron
- 1.22 -Coefficient in the Rayleigh criterion
- 2.7 K -Temperature of the cosmic microwave background
- $3 \times 10^{-3} \text{ m.K}$ -Wien's Law coefficient

Let's get started from the notes that I have taken for my pGRE test. I will use the convention of numbering on for the equation that is worth to memorize for the test.

1 Classical Mechanics (20%)

It includes kinematics, Newton's laws, work and energy, oscillatory motion, rotational motion about a fixed axis, dynamics of systems of particles, central forces and celestial mechanics, three-dimensional particle dynamics, Lagrangian and Hamiltonian formalism, non-inertial reference frames, and elementary topics in fluid dynamics.

1.1 Kinematics

1.1.1 Linear Motion in the inertial frame of reference

Average velocity

$$v = \frac{\Delta x}{\Delta t} = \frac{x_2 - x_1}{t_2 - t_1}$$

Instantaneous velocity

$$v = \lim_{\Delta t \rightarrow 0} \frac{\Delta x}{\Delta t} = \frac{dx}{dt} = v(t)$$

Acceleration

$$a = \lim_{\Delta t \rightarrow 0} \frac{\Delta v}{\Delta t} = \frac{dv}{dt} = a(t)$$

If acceleration is zero then, the velocity will be constant. Likewise, if velocity is constant then, acceleration will be zero.

Kinematic equations of motion under constant acceleration: SUVAT rule

$$v = u + at \tag{1}$$

$$(x - x_0) = s = ut + \frac{1}{2}at^2 \tag{2}$$

$$v^2 = u^2 + 2as \tag{3}$$

$$(x - x_0) = \frac{1}{2}(u + v)t \tag{4}$$

1.1.2 Projectile motion

To solve projectile motion related problems, we only need equations of motion for *two dimensions*. This is because if you observe an object moving in the projectile motion, you will only see two components to study this motion. But I want to aware you this is not true for an object which is moving in a curvy way (or, approximately zigzag or spiral). For example, boomerang. So, for the projectile motion, we only need is

$$\begin{aligned} \text{in } x\text{-axis: } x(t_1) &= x(t_0) + u_x t_1 \\ \text{, and in } y\text{-axis: } y(t_1) &= y(t_0) + u_y t_1 - \frac{1}{2} g t_1^2 \end{aligned}$$

where u_i refers to initial velocity in i -axis. In this type of motion, we assume an object will only falling under the influence of gravity so, we have additional term which is highlighted by gray color. In order to have mathematically correct equation, we also need negative sign in-front of it which suggest us, we need to change the direction of gravity along with the y -axis direction.

1.1.3 Uniform circular motion

The most simplest form of an orbit is circular path in-which its acceleration vector is decomposed into radial and tangential components. If its tangential acceleration is zero which means its tangential velocity is constant then, we can have uniform circular motion about the center of circle. This means if you see tangential velocity be constant then, you can think of the problem is related to circular motion. There must be radially inward force acting on the object which we called as centripetal force. Thus, it keeps an object moving in a circular path with constant speed¹. But, keep in mind that its radial acceleration is non-zero.

Radial or centripetal acceleration

$$a = \frac{v^2}{r}$$

Angle

$$\theta = \frac{\text{arc}}{\text{radius}}$$

¹We use “speed” instead of velocity because we consider our velocity to be constant that means we don’t need to deal with the direction of this velocity. Because whatever the direction is, its magnitude of the velocity remains same. But note it, its magnitude play a very crucial role to be in a circular path.

Angular velocity

$$\omega = \lim_{\Delta t \rightarrow 0} \frac{\Delta \theta}{\Delta t}$$

Relation of v and ω

$$v = r\omega \quad (5)$$

Relation of a and ω

$$a = r\omega^2 \quad (6)$$

Angular acceleration

$$\alpha = \lim_{\Delta t \rightarrow 0} \frac{\Delta \omega}{\Delta t}$$

Rotational equation of motion under constant angular acceleration

$$\omega = \omega_0 + \alpha t \quad (7)$$

$$\theta = \omega_0 t + \frac{1}{2} \alpha t^2 \quad (8)$$

$$\omega^2 = \omega_0^2 + 2\alpha\theta \quad (9)$$

$$\theta = \frac{1}{2}(\omega_0 + \omega)t \quad (10)$$

Centripetal or radial force

$$F_{\text{radial}} = \frac{mv^2}{r} \quad (11)$$

If you see any problem related to circular motion then, any force (i.e. gravitational force or magnetic force or tension on the string) can be equal to centripetal force.

$$\text{Any force} = F_{\text{radial}}$$

For example: In an uniform magnetic field which is perpendicular to the direction of motion of a particle then, its tangential velocity will be constant and can be considered the problem of circular motion.

1.2 Newton's laws of motion

First law: A body continues in its state of rest or *uniform motion* unless any external *unbalanced force* act upon it.

Second law: The net force *on* a body is proportional to its rate of change of *linear momentum*.

$$F = \frac{dp}{dt} = ma$$

Third law: When a particle A exerts a force on another particle B (i.e. F_{AB}), B simultaneously exerts a force on A (i.e. F_{BA}) with the *same magnitude* in the *exactly opposite direction*.

$$F_{AB} = -F_{BA}$$

1.3 Frictional Force

$$F_f = \mu \times F_N \quad (12)$$

where, F_f refers to frictional force, F_N refers to normal force, and μ refers to coefficient of the friction.

Tips

- When interactions between the blocks become important, for example when they exert forces on one another through friction, then we must usually treat them as independent objects.
- If one block of mass “m” is sits on the top of the another block of mass “M”, and the blocks don't slip then, two bodies are behaving as one with mass of (m+M). This means, μ depends on the combination of “m” and “M”, rather than “m” or “M” individually. Also, both the blocks will experience the same acceleration. This makes our problem-solving time faster because we will only use the above concepts and Newton's second law. But not the free body diagram procedure which is actually time-consuming.
- We change physical quantities in the form of components consists of *sin* and *cos*. So, we need to remember that at the angle of 45° , $\sin(45^\circ) = \cos(45^\circ)$ which will make our calculation much simpler.
- If a spherical or cylindrical object move by rolling (not by slipping) then, frictional force is responsible for it. So, we can neglect translation kinetic energy, and only use rotational kinetic energy. Remember, frictional force only causes rotational motion and which is instantaneous, so you can say frictional force has done negligible work thus, you don't have to account the frictional energy (i.e. $F_f \times \text{distance}$).

1.4 Energy

The most important physical quantity called energy has its own conservation law which helps to solve many problems related to it. And this says: “*Energy neither be created nor be destroyed, but can be transform from one form to another*”. For example: kinetic to potential.

1.4.1 Energy conservation for conservative force

If an object is acted on only by *conservative* forces (i.e. the work done by the force is independent of path. For e.g. gravitational, magnetic, electrical, spring force and etc) then, the sum of the kinetic and potential energies always remains *constant* along the object’s path. i.e. $E_{\text{initial}} = E_{\text{final}}$. You can use this concept in the problems like elastic collision.

1.4.2 Energy conservation for non-conservative force

For non-conservative force, $E_{\text{initial}} \neq E_{\text{final}}$. So, we need to add extra term in which energy is converted into another form. i.e. $E_{\text{initial}} + W_{\text{other}} = E_{\text{final}}$ where W_{other} is the work done by non-conservative force. This is we called as *work-energy theorem*. The most common example of the non-conservative force is frictional force. You can use this concept in the problems like in-elastic collision.

Tips

- Use *conservation of energy*, when we need to calculate how fast (i.e. velocity ?) and how far (i.e. position ?) something goes. Because this law only uses kinetic energy (which depend on velocity), and potential energy (which depend on positions).
- Use *Kinematics*, when we need to calculate how much time something takes. Because the position and velocity is explicitly a function of time.

So, the right choice from these can helps us to solve the problem very fast.

1.4.3 Types of energies

The most common types of energies are:

$$\text{Translation kinetic energy (T.KE)} = \frac{1}{2}mv^2 \quad (13)$$

$$\text{Rotational kinetic energy (R.KE)} = \frac{1}{2}I\omega^2 \quad , \text{ where } I \text{ means moment of inertia} \quad (14)$$

Kinetic energy for a body

$$\text{about its center of mass} = \text{(T.KE)} + \text{(R.KE)} \quad (15)$$

$$\text{Gravitational potential energy} = mgh \quad , \text{ always use value of } g \text{ to be } 10 \text{ m/s}^2 \quad (16)$$

$$\text{Spring potential energy} = \frac{1}{2}kx^2 \quad , \text{ where } k \text{ means spring constant} \quad (17)$$

So, the simplest trick you can use while doing most of the problems is:

Other forms of energy = Potential energy

1.5 Momentum

Linear momentum: $p = mv$

Angular momentum: $L = I\omega$

1.5.1 Relation between angular and linear momentum

$$L = r \times p \quad (18)$$

where \times is the cross-product. This expression is only used when we need to account the system which is build out of smaller pieces. So, you can simply use $L = I\omega$ for the compact/dense system.

1.5.2 Conservation of Momentum

Like conservation of energy, momentum is always conserved in a system in the absence of an external forces. i.e.

Total initial momentum = Total final momentum

Always give conservation of momentum as a first priority. Because you cannot use conservation of energy 1.4.1 for in-elastic collision but, you can still use conservation of momentum.

1.6 Torque

It is also called as moment or moment of force or rotational force.

$$\begin{aligned} \tau &= \frac{dL}{dt} \\ \tau &= r \times F \end{aligned} \quad (19)$$

1.7 Moment of Inertia

It is also called as rotational inertia or angular mass. So, moment of inertia can be analogous to an inertial mass² (or simply mass).

²Inertial mass measures an object's resistance to being linearly accelerated by a force (represented by the relationship $F = ma$). Similarly, angular mass measures an object's resistance to being angularly accelerated by a rotational force.

A point particle of mass m :

$$I = mr^2$$

A system of many particles:

Its moment of inertia is the sum of the individual moments of inertia. But, for an object with infinitely many particles:

$$I = \int r^2 dm$$

where, dm is an infinitesimal mass element and r is the distance from the point to the axis of rotation.

1.7.1 Parallel axis theorem

It says, if you know the moment of inertia of a system of mass M rotating about an axis through its center of mass (CM), then its moment of inertia about *any axis parallel* to the CM axis is:

$$I = I_{\text{CM}} + Mr^2. \quad (20)$$

In pGRE formula sheets, the test taker provides moment of inertia for solid objects like rod, disc, and sphere. Remember, *the moment of inertia about the CM axis for a solid cylinder is same as of disc which is not given in the sheet.* i.e. $\frac{1}{2}Mr^2$.

1.8 Center of Mass

It is a point (like a fulcrum) which balances the two sides.

A system of point masses

$$r_{\text{CM}} = \frac{\sum_i r_i m_i}{\sum_i m_i}$$

A system of bulk mass

$$r_{\text{CM}} = \frac{\int r dm}{\int dm}$$

Confused words in the Classical Mechanics

- *String* (i.e. straight wire or thread) and *Spring* (i.e. a helical metal coil).
- *Gravity* (i.e. gives the answer why every objects fall towards the earth) and *Cavity* (i.e. a hollow space inside solid or liquid)
- *Geostationary orbit* and *Geosynchronous orbit* are just a synonym of each others.
- *Rotation* (i.e. rotate around its own axis) and *Revolution* (i.e. rotate around the heavier object)

If you see *extremum* in the problem, think of the *principle of least action* which is the integral of Lagrangian with respect to time, and the equation of motion are generally always time dependent, not position dependent.

1.9 Kepler's laws of planetary motion

First law: Planets move in elliptical orbits with one focus at the sun.

Second law: Planetary orbits sweep out equal areas in equal interval of time.

Third law: The square of the orbital time period T of a planet is directly proportional to the cube of the semi-major axis r of its orbit.

$$T^2 \propto r^3$$

If you question says point mass then assume the mass of it to be 1 kg.

2 Electromagnetism (18%)

It includes electrostatics, current and DC circuits, magnetic fields in free space, Lorentz force, induction, Maxwell's equations and their applications, electromagnetic waves, AC circuits, and magnetic and electric fields in matter.

Kirchhoff's voltage loop law says the sum of all voltages about a complete circuit must sum to zero. This is very important law when a circuit problem is given.

In a region where there are no charges inside but with a uniform potential on the surface then, the potential inside the center is exactly same that of surface.

The most ubiquitous Gauss's law is

$$\nabla \cdot \vec{E} = \frac{\rho}{\epsilon_0}$$

where ρ is the total electric charge density (charge per unit volume).

The exponent in Coulomb's inverse square law has been found to differ from two by less than one part in a billion by measuring the electric field inside a charged conducting shell and the experiment was Faraday's Ice Pail.

The shielding on the coaxial cable is to reduce the interference with other electronic equipment so, there is no any presence of electromagnetic waves outside the cable.

If there is grounded conducting plane at the center $x = 0$ and a charge q at a distance of a then, there is also an image charge $-q$ which is at $-a$ from the center.

In capacitor, we have $Q = CV$ and its energy is $U = \frac{1}{2}CV^2$. For the circuit which follows ohms law, we have $V = IR$. Also,

$$X = X_0 e^{\frac{-tn}{RC}} \quad (21)$$

where X can be I or V with $n = 1$, or U with $n = 2$.

Maxwell's equations of electromagnetism in the absence of magnetic or polarizable medium/matter (also called as Maxwell's microscopic equations) are

$$\text{Gauss's law for electricity: } \nabla \cdot E = \frac{\rho}{\epsilon_0}$$

$$\text{Gauss's law for magnetism: } \nabla \cdot B = 0$$

$$\text{Faraday's law of induction: } \nabla \times E = -\frac{\partial B}{\partial t}$$

$$\text{Ampere's circuital law: } \nabla \times B = \frac{1}{c^2} \left(J + \frac{\partial E}{\partial t} \right)$$

where, $k = \frac{1}{4\pi\epsilon_0}$ is Coulomb's constant, $c = \frac{1}{\sqrt{\mu_0\epsilon_0}}$ is the velocity of light, $J = \frac{\text{Current}}{\text{Area}}$ is current density, $\rho = \frac{\text{Charge}}{\text{volume}}$ is charge density, ϵ_0 is vacuum permittivity (i.e. capability of the vacuum to permit electric field lines, and dielectric constant³ $k = \frac{\epsilon}{\epsilon_0}$), μ_0 is vacuum permeability (i.e. capability of the vacuum to permit magnetic field lines).

Maxwell's equations of electromagnetism in the presence of magnetic or polarizable medium/matter (also called as Maxwell's macroscopic equations) are

$$\text{Gauss's law for electricity: } \nabla \cdot D = \rho$$

$$\text{Gauss's law for magnetism: } \nabla \cdot B = 0$$

$$\text{Faraday's law of induction: } \nabla \times E = -\frac{\partial B}{\partial t}$$

$$\text{Ampere's circuital law: } \nabla \times H = J + \frac{\partial D}{\partial t}$$

where, $D = \epsilon_0 E + P$ is displacement vector, P is a polarization vector and H is the magnetic field strength of a medium. Displacement vector can be relate as $B = \mu_0(H+M)$ where M is magnetization. For free space, polarization vector and magnetization are zero and i.e. $D = \epsilon_0 E$ and $B = \mu_0 H$.

If magnetic monopoles exist then, two Maxwell's equations will be wrong. i.e. Gauss's law for magnetism and Faraday's law of induction.

3 Quantum Mechanics (12%)

It includes fundamental concepts, solutions of the Schrödinger equation (like square wells, harmonic oscillators and hydrogen atoms), spin, angular momentum, wave function, symmetry, and elementary perturbation theory.

³also called relative permittivity ϵ_r

3.1 Probability of wave function

The probability of finding a particle with wave function $\psi(x, t)$ within the volume⁴ dv is $|\psi(x, t)|^2 dv$. So, the total probability $\int_{-\infty}^{\infty} |\psi(x, t)|^2 dv = 1$. The wave function must be normalized and wave function should vanish exactly at $-\infty$ to ∞ . For revision, we only consider one dimension most often.

3.1.1 Dimension of wave function

You can get its dimension by applying dimensional analysis in the total probability of wave function. i.e.

$$\text{Dimension} = L^{-d/2} \quad (22)$$

where, d is the spatial dimensions.

3.2 Hermitian operator

Hermitian is defined as a transpose of complex conjugate. An operator is said to be Hermitian operator if $\hat{A}^\dagger = (A^*)^T = \hat{A}$ or to be more precise

$$\int_{-\infty}^{\infty} f(x)^* (\hat{A}g(x)) dx = \int_{-\infty}^{\infty} (\hat{A}f(x))^* g(x) dx. \quad (23)$$

Here are some facts about Hermitian operator:

- All their eigenvalues are real.
- Eigenfunctions corresponding to different eigenvalues are orthogonal. i.e.

$$\int_{-\infty}^{\infty} f(x)^* g(x) dx = 0.$$

3.3 Observables in-term of Hermitian operator

$$\langle \hat{A} \rangle = \int_{-\infty}^{\infty} \psi^* \hat{A} \psi dx$$

In quantum mechanics, observables and operators are often interchangeable. An observable refer to a physical quantity whereas operator refers to its mathematical representation i.e. matrix.

⁴For one-dimension, volume is length of a line i.e. positions $(x, x + dx)$.

3.4 Dirac notation

$\langle a|$ refers to *bra* and $|b\rangle$ refers to *ket* which is as a whole refers to bra(c)ket notation or Dirac notation. The inner product of $\langle a|$ and $|b\rangle$ is $\langle a|b\rangle$ where $\langle a|$ is a row vector a (also, a hermitian conjugate of $|a\rangle$), and $|b\rangle$ is column vector b . Just for knowledge not for pGRE, the state of a wave function can be modeled as a set of points in a Hilbert space which allows us to measure length and angle due to inner product.

Here are some results of this notation that is good to remember. i.e.

- Complex conjugate of inner product, $\langle a|b\rangle = \langle b|a\rangle^*$.
- An operator \hat{A} on $|b\rangle$, $\hat{A}|b\rangle = |\hat{A}b\rangle$.
- Hermitian conjugate of \hat{A} i.e. \hat{A}^\dagger , $\langle a|\hat{A}b\rangle = \langle \hat{A}^\dagger a|b\rangle = \langle \hat{A}a|b\rangle$ because $\hat{A}^\dagger = \hat{A}$.
- Function in the Dirac notation, $\langle x|f\rangle = f(x)$.
- Inner product on function space, $\langle f|g\rangle = \int_{-\infty}^{\infty} f(x)^*g(x)dx$.
- Observable A in the Dirac notation, $\langle \hat{A}\rangle = \int_{-\infty}^{\infty} \psi^*\hat{A}\psi dx = \langle \psi^*|\hat{A}|\psi\rangle$.

3.5 Quantum operators

It is easy to remember quantum operators on a single axis than a general form.

$$\text{Position, } \hat{x} = x$$

$$\text{Momentum, } \hat{p} = -i\hbar\frac{\partial}{\partial x}$$

$$\text{Kinetic energy, } \hat{T} = \frac{\hat{p}^2}{2m} = -\frac{\hbar^2}{2m}\frac{\partial^2}{\partial x^2}$$

$$\text{Hamiltonian, } \hat{H} = \hat{T} + \hat{V} = -\frac{\hbar^2}{2m}\frac{\partial^2}{\partial x^2} + \hat{V}(x)$$

$$\text{Total Energy for time-dependent potential, } \hat{E} = i\hbar\frac{\partial}{\partial t}$$

$$\text{Total Energy for time-independent potential, } \hat{E} = E$$

$$\text{Angular momentum, } \hat{L}_x = -i\hbar\left(y\frac{\partial}{\partial z} - z\frac{\partial}{\partial y}\right)$$

$$\hat{L}_y = -i\hbar\left(z\frac{\partial}{\partial x} - x\frac{\partial}{\partial z}\right)$$

$$\hat{L}_z = -i\hbar\left(x\frac{\partial}{\partial y} - y\frac{\partial}{\partial x}\right)$$

3.6 Schrödinger equation

You can find the wave function from the solution of Schrödinger equation.

$$\hat{H}\psi(x, t) = \hat{E}\psi(x, t) \tag{24}$$

3.6.1 Time dependent

$$\left(-\frac{\hbar^2}{2m}\frac{\partial^2}{\partial x^2} + \hat{V}(x)\right)\psi(x,t) = i\hbar\frac{\partial}{\partial t}\psi(x,t)$$

3.6.2 Time independent

$$\left(-\frac{\hbar^2}{2m}\frac{\partial^2}{\partial x^2} + \hat{V}(x)\right)\psi(x,t) = E\psi(x,t)$$

A transition in which one photon is radiated by the electron in a hydrogen when the electron's wave function changes from ψ_1 to ψ_2 is forbidden if ψ_1 and ψ_2 are both spherically symmetrical. Because any change of state must be accompanied by a change in the quantum angular momentum number $\Delta l = \pm 1$.

4 Thermodynamics and Statistical Mechanics (10%)

It includes the laws of thermodynamics, thermodynamic processes, equations of state, ideal gases, kinetic theory, ensembles, statistical concepts, calculation of thermodynamics quantities, thermal expansion, and heat transfer.

In Carnot engine, the entropy of the system should be perfectly conserved. i.e. $dS = 0$. The maximum efficiency of a Carnot engine is,

$$\eta = \frac{\text{Workdone}}{\text{Heat input}} = 1 - \frac{\text{Absolute temperature of cold reservoir}}{\text{Absolute temperature of hot reservoir}} \quad (25)$$

The mean free path equation for the probability of stopping a particle moving through medium is

$$P(x) = n\sigma dx \quad (26)$$

where $P(x)$ is the probability of stopping the particle in the distance dx , n is the nuclei, σ is the scattering cross section and dx is the thickness of the scatterer.

According to Stefan's law (to be more specific, Stefan-Boltzmann's), power radiation of a blackbody is only dependent on temperature which is

$$j = \sigma T^4 \quad (27)$$

where σ is a Stefan's constant. So, if you see a problem related to blackbody, remember that law.

Heat capacity of a molecule is determined by the number of degrees of freedom of the molecule. For example, in a mono-atomic gas, the heat capacity at constant volume is $C_V = \frac{3}{2}R$. For diatomic molecule connected by spring, we have additional degree of freedom due to vibration and rotation then, the heat capacity will be $\frac{3}{2}R + R + R = \frac{7}{2}R$.

5 Atomic Physics (10%)

It includes properties of electrons, Bohr's model, energy quantization, atomic structure, atomic spectra, selection rules, black-body radiation, X-rays, atoms in electric fields, and atoms in magnetic fields.

If an external electron strikes and knocks the innermost electron then, another electron will jump into that place such occurs K ($n \geq 2 \rightarrow n = 1$), L ($n \geq 2 \rightarrow n = 2$), M ($n \geq 2 \rightarrow n = 3$), L ($n \geq 2 \rightarrow n = 4$) series transition. For the specific transition, the minimum transition *energy* is given by *Moseley's law*,

$$E = R_e(Z - \beta)^2 \left(\frac{1}{n_{\text{final}}^2} - \frac{1}{n_{\text{initial}}^2} \right) \quad (28)$$

where, R_e is the Rydberg's energy (or constant) which is equal to 13.6 eV. Because the ground state energy of Hydrogen atom is referred as 1 Rydberg. And Rydberg's constant is mass dependent. i.e.

$$R_{\text{hydrogen}} = \frac{m_e m_p}{m_e + m_p} \frac{e^4}{8c\epsilon^2 h^3}$$

The ratio of the mass of proton to electron is 1836:1.

Atoms with a single electron in its outer shell can be thought of as analogous to a hydrogen atom and it has the electron charge distribution to be spherically symmetrical.

From the Bohr model, we get the approximations of any hydrogen like atoms as

$$E_n = -\frac{Z^2 R_e}{n^2}$$

Radioactive elements have very low binding energy in-compared to others. The standard deviation for radioactive emission is described by the Poisson noise, $\sigma = \sqrt{\lambda}$ where λ is the average number of radioactive samples.

Compton scattering is the phenomena by which photons collide with a particle, impart some of their kinetic energy to the particle and then scatters off at a lower energy. The compton equation is,

$$\lambda_{\text{final}} - \lambda_{\text{initial}} = \frac{h}{mc}(1 - \cos(\theta)) \quad (29)$$

where λ is the wavelength of photon, m is its mass and θ is the scattering angle.

The Franck-Hertz experiment and related scattering experiments show us that at a specific energy range (4.9 volts to be specific in Franck-Hertz experiment) electrons begin to experience inelastic collisions and that energies lost in the collision came in discrete amounts.

The energy range for Photoelectric effect is measured in eV and that of Compton effect is in KeV, and pair production is in MeV.

6 Optics and wave phenomena (9%)

It includes wave properties, superposition, interference, diffraction, geometrical optics, polarization, and Doppler effect.

Hologram is generated as the result of interference between two light beams and wave interference is dependent on wave phase.

The group velocity v_g is related to the angular frequency ω is

$$v_g = \frac{\partial \omega}{\partial k} \quad (30)$$

where k is the magnitude of the propagation (or, wave) vector.

The Bragg's law of diffraction is $2d \sin(\theta) = n\lambda$

The de-Broglie equation is $\lambda = \frac{h}{p}$.

7 Specialized topics (9%)

It includes Nuclear physics (e.g., nuclear properties, radioactive decay, fission reactions, and fusion reactions), Particle physics (e.g., fundamental properties of elementary particles), Condensed Matter physics (e.g., crystal structure, x-ray diffraction, thermal properties, electron theory of metals, semiconductors, and superconductors), and Miscellaneous (e.g., Astrophysics, Mathematical methods, and Computer applications).

The Hall effect is used in solid-state physics to measure the sign of the charge carriers.

One feature common to both Debye theory and the Einstein theory of the specific heat of a crystal composed of N identical atoms is that the vibrational energy of the crystal is equivalent to the energy of $3N$ independent harmonic oscillators.

7.1 Mathematical methods

It includes single and multivariate calculus, co-ordinate systems (rectangular, cylindrical and spherical), vector algebra and vector differential operators, Fourier series, partial differential equations, boundary value problems, matrices and determinants, and function of complex variables.

8 Special Relativity (6%)

It includes introductory concepts of relativity, simultaneity, energy and momentum, four-vectors, Lorentz transformation, velocity addition, time dilation, and length contraction.

The pseudo pythagorean theroem commonly called as spacetime interval is,

$$\Delta s^2 = -c\Delta t^2 + \Delta r^2 \quad (31)$$

If initially there is only an electric field, after the Lorentz transformation, there may be both an electric and a magnetic field. This is how an electromagnetic field behaves under a Lorentz transformation.

9 Laboratory methods (6%)

It includes data and error analysis, electronics, instrumentation, radiation detection, counting statistics, interaction of charged particles with matter, lasers and optical interferometers, dimensional analysis, and fundamental applications of probability and statistics.
